# Advisory Council Monetary and In-Kind Donations Guidelines and Forms

## I. General Guideline and Requirements for In-Kind or Monetary Donations

Pursuant to Chicago Park District (CPD) Advisory Council Guidelines, **The Chicago Women's Park and Gardens / Park 550 Advisory Council** may work together with the Chicago Park District Staff, residents, community organizations, and businesses to seek monetary and in-kind donations to improve park facilities, capital assets, and programming. As funds or equipment obtained by the Advisory Council will ultimately be used for public purpose, there are certain guidelines for ***In-kind*** and ***Monetary donations for donors to utilize:***

1. **Reporting** - Advisory council must report monetary or in-kind donations (such as temporary equipment, refrigerators, computers or other similar assets) to the CPD.
2. ***In-kind Donations***- The respective Park Supervisor or Staff will complete a Donation Acceptance Form (Use attached ***ADVISORY COUNCIL IN-KIND DONATION ACCEPTANCE FORM***) to ensure donations are tracked or approved.

Please remember that any equipment or in-kind donation becomes the property of the CPD, and as such, the CPD has the right to use them as it deems safe and necessary.

3. ***Monetary Donation*** - Monetary donations ***The Chicago Women's Park and Gardens / Park 550 Advisory Council*** should include a letter identifying the donation amount, purpose of the donation and a copy of the payment. (Use attached ***MONITARY DONATION FORM - Chicago Women's Park and Gardens / Park 550 Advisory Council***)

Donors will also be able to donate on-line via the Advisory Council Website using **PayPal** or equivalent tool)

4. ***Acceptance*** - The CPD also has the right to refuse to accept any in-kind donation or capital improvement project at its sole discretion.

## II. In-Kinds Donation Needs:

- Gently Used or New Books for Toddler and Preschool Age Children
- Gently Used or New Toys that Promote Group Play for Toddler and Preschool Age Children. Examples: Large Legos, Building Blocks, Large Car Toys, Train Sets, Pretend & Play Sets,
- Gently Used or New Toys that Promote Learning for Toddler and Preschool Age Children. Example: Wooden Puzzles, Puppets, Counting Toys, Lacing Boards/Beads
- Arts and Crafts Supplies. Examples: Yarn, Construction Paper, Stickers, Googly Eyes
- Holiday Decorations
